UK Government Legislative Programme 2005-06: Outcome of Bills

1 Introduction

The UK Parliament was prorogued on Wednesday 08 November ahead of the State Opening of the new session of Parliament on Wednesday 15 November 2006. A number of Bills in the UK Government's legislative programme for the 2005-06 session failed to receive Royal Assent before prorogation.

Of the nineteen Bills remitted to Assembly Committees, sixteen received Royal Assent. Of those outstanding, two were withdrawn. The remaining Bill was a draft Bill and the relevant Assembly committee responded to a consultation on the proposals.

This paper covers the details and outcome of the Bills formally remitted to Assembly committees, and other Bills of likely interest.

It also includes a complete list of Public Bills in the 2005-06 session.
