UK Government Legislative Programme 2004-05: Outcome of Bills

1 Introduction

The UK Parliament was dissolved on Monday 11 April ahead of the General Election to be held on 5 May 2005. A number of Bills in the UK Government's legislative programme for the 2004-05 session failed to receive Royal Assent before the dissolution of Parliament.

This paper includes details, including the outcome, of those Bills that had been formally remitted to the Assembly's Subject Committees, and other Bills of possible interest to Committees.

It also includes a complete list of Public Bills in the 2004-05 session, indicating their success or failure.

It formalises the merger of the two National Lottery distribution bodies - the Community Fund and New Opportunities Fund - into the Big Lottery Fund.

The Bill contains provisions relating both to England and Wales, as well as Wales-only and England-only provisions. In many of the cases where provisions relate to England and Wales, the Assembly will decide how, when and whether they are implemented in Wales.

Charities Bill [HL]	Bill dropped Latest Parliamentary stage reached: Committee stages February & March 05	The Bill would modernise the law governing the voluntary sector, with a new definition of charitable work. It includes provision for the Secretary of State for Wales to appoint the Charity Commissioner for Wales.
European Union Bill	Bill dropped Latest Parliamentary stage reached: Second reading 09/02/05	The Bill would pave the way for a referendum on the new European Union constitution, expected to be held in early 2006. It includes provision for the referendum question on the EU constitution to be asked in Welsh in Welsh polling stations.
Identity Cards Bill	Bill dropped Latest Parliamentary stage reached: Passed through Commons, Lords second reading 21/03/05	The Bill would introduce compulsory identity cards to tackle terrorism, asylum abuses and identity fraud. It would allow the Assembly to decide whether the card should be a requirement for using devolved public services.
Inquiries Bill [HL]	Royal Assent 07/04/05 Inquiries Act 2005 (Ch. 12)	The Bill would modernise the system for holding public inquires, with the aim of making the reviews quicker and fairer for witnesses. It would give the Assembly power to set up inquiries into devolved issues and to hold joint inquiries.
Road Safety Bill	Bill dropped Latest Parliamentary stage reached: Passed through Commons, Lords first reading 09/03/05	Police would be given new powers to tackle drink driving and uninsured drivers. It would give the Assembly powers re: funding road safety projects and running re-training courses. It would amend the Assembly's existing powers re: Drink Driving Rehabilitation Scheme.

School Transport Bill

Bill dropped Latest Parliamentary stage reached: Passed through Commons, Lords Committee stages March 05 Carried over from the last session, the Bill would allow local authorities to "provide innovative and safe school transport". It would give the Assembly powers to make some regulations and orders relating to Wales.
